ITEM NO. 3 on the agenda UPDATE AND POSSIBLE DISCUSSION REGARDING A RECENT SEWER ISSUE LOCATED ON NW 46TH STREET BETWEEN ASBURY AND MUELLER. (BRADD BROWN, CITY MANAGER)

City Manager Bradd Brown updated city council on the private sewer line that serves 4 houses and the maintenance facility for Bethany High School. This line taps into a manhole that is in the middle of NW 46th Street. A plumber was obtained by one of the homeowners and he discovered that the line was partially collapsed. A permit was not able to be obtained due to the noncompliance. An emergency exception was authorized by City Manager Bradd Brown to grant a special permit to replace that portion of the collapsed line. It was also discovered that a portion of the line that goes under the pavement also has some issues.

Deputy City Manager/City Engineer Steve Katen gave some details, recommendations and answered questions from the council.

Holly Anderson of 6720 NW 46th Street spoke on the history of this being an

issue for several years for homeowners. She explained that she has replaced the trunk line however, the part at the street is another \$6,000. She requests the city to take care of the part that runs under the street.
