

NOTICE CONCERNING GARAGE SALES

SECTION 10-109 GARAGE SALES; LIMITATIONS; OFFENSES

- A. Garage sales may be conducted by the residents and on the premises of occupied residential properties within the City of Bethany only under the following conditions:
1. A City permit shall be obtained prior to a garage sale under the provisions of Section 10-103 of the Bethany Code of Ordinances.
 2. Sales tax will be reported and paid on all sales of merchandise in accordance with the Oklahoma Sales Tax Code.
 3. Garage sales will be limited to five (5) days per year per location.
 4. Only merchandise incidental to the occupancy of the residence may be sold, i.e. no merchandise shall be sold which is purchased for resale or brought onto the premises for resale. Flea market-type sales where new or used merchandise not incidental to occupancy of the premises is brought to the premises for sale are prohibited under garage sale permits.
 5. A copy of the permit shall be prominently displayed on the premise throughout the sale.
 6. A permit for an estate sale may be issued under the above conditions where the sale is conducted on the premises of the deceased person.
- B. It shall be unlawful and an offense to conduct or allow the conduct of a garage sale except as provided in this section.

SECTION 13-410 SIGN PERMITS

- A. Authorizes you to erect signs for garage sales, provided that:
1. A garage sale permit has been issued.
 2. The permit number is displayed on the sign face of all signs.
 3. No sign exceeds 3 square feet in area.
 4. No sign is posted more than 4 days prior to the sale.
 5. All signs are removed within 2 days after the sale.
 6. No sign is posted on any curb, sidewalk, utility post or pole, hydrant, bridge, tree, or other surface located on public property, or any public right-of-way.
- B. Any sign found violating any of the above will be removed
- C. This ordinance does not prohibit you from erecting your signs on or in front of the property of another. However, Ordinance 11-209 does prohibit you from doing so without first obtaining that owner's consent.

Any person who violates Ordinances 10-109, 13-410, 11-209, or 10-103(6) may be subject to a fine of \$500.00 per day for each violation. We therefore urge you to observe the conditions listed in this notice.
